You are hereby notified that I have amended Approval No. 2871-8UKGPC issued on June 15, 2012 for a Class 4 wind facility with a total name plate capacity of 270 megawatts (MW), as follows:

A. The definition of Acoustic Assessment Report on page 1 of the Approval is deleted and replaced with the following:

1. "Acoustic Assessment Report" means the reports entitled :
 - i. Samsung Renewable Energy Inc. and Pattern Energy, 8 Noise Study Report for South Kent Wind Project Rev. 4, dated May 7, 2012, prepared by Hatch and signed by Oleg Belashov P.Eng; and
 - ii. Samsung Renewable Energy Inc. and Pattern Energy, 8 Noise Study Report for South Kent Wind Project Rev. 7, dated May 7, 2013, prepared by Hatch and signed by Mervin Choy P.Eng;

B. The definition of Application on page 2 of the Approval is deleted and replaced with the following:

10. "Application" means the application for a Renewable Energy Approval dated September 24, 2011, and signed by Colin Edwards, Director, South Kent Wind GP Inc., on behalf of South Kent Wind LP and all supporting documentation submitted with the application, including amended documentation up to June 15, 2012; and the amendment application dated April 9, 2013 and signed by Colin Edwards, Director, South Kent Wind GP Inc., on behalf of South Kent Wind LP, and all supporting documentation submitted with the Application, including amended documentation submitted up to the date this Approval is issued;

NOTICE REGARDING HEARINGS

In accordance with Section 139 of the Environmental Protection Act, within 15 days after the service of this notice, you may by further written notice served upon the Director, the Environmental Review Tribunal and the Environmental Commissioner, require a hearing by the Tribunal.

In accordance with Section 47 of the Environmental Bill of Rights, 1993, the Environmental Commissioner will place notice of your request for a hearing on the Environmental Registry.

Section 142 of the Environmental Protection Act provides that the notice requiring the hearing shall state:

1. The portions of the renewable energy approval or each term or condition in the renewable energy approval in respect of which the hearing is required, and;
2. The grounds on which you intend to rely at the hearing in relation to each portion appealed.

The signed and dated notice requiring the hearing should also include:

3. The name of the appellant;
4. The address of the appellant;
5. The renewable energy approval number;
6. The date of the renewable energy approval;
7. The name of the Director;
8. The municipality or municipalities within which the project is to be engaged in;


