

SOUTH KENT WIND LP NOTICE OF THE CREATION OF A COMMUNITY LIAISON COMMITTEE

Purpose:

South Kent Wind LP ("SKW") received the Renewable Energy Approval ("REA") for the South Kent Wind Project (the "Project") in June 2012 and will be forming a Community Liaison Committee ("CLC"). The formation of a CLC for the construction and operation phase of the Project reflects a continuation of positive interaction with the community, and meets the requirement set forth in the REA. The CLC will provide an opportunity for ongoing, two-way communication and information sharing to assist in the identification and resolution of current and potential community issues related to the construction, installation, use, operation, maintenance, and retirement of the Project. A facilitator has been retained to organize and coordinate the CLC.

SKW is actively seeking a range of members to participate in the CLC including, without limitation:

- Participating landowners
- Neighbouring landowners
- First Nations and Aboriginal community members
- Other members of the public
- Government agencies
- Members of the local agricultural and business communities
- Local organizations and special interest groups

The CLC is anticipated to be comprised of approximately twenty (20) members and all meetings will be open to the public for observation. CLC membership selection will be based primarily on the need for a balanced perspective on the Project to facilitate effective discussion. Members will be responsible for attending a minimum of four (4) meetings over a two year period. Meetings will take place on a weekday evening and lasting approximately two hours each. The first CLC meeting is anticipated to take place in the fall 2012.

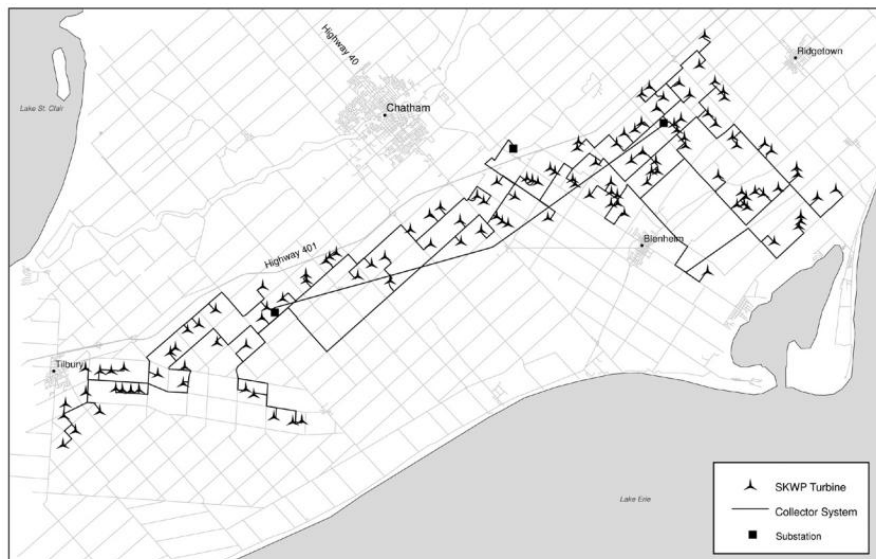

South Kent Wind Project Facts

The Project is located in the Municipality of Chatham-Kent, south of Highway 401 between the communities of Tilbury and Ridgetown, as indicated on the key map below. The Project is a 270 MW wind energy project consisting of approximately 124 operational wind turbines, along with supporting infrastructure, which includes access roads, construction and turnaround areas and buried and/or overhead collection/transmission lines. The collection/transmission system will include a 230 kV transmission line and two (2) substations, in order to connect to the Chatham Switching Station.

The Project will create approximately 300 jobs during construction and approximately 20 permanent positions, in addition to contracting the services of many local businesses. The Project will also generate an estimated \$800,000 in annual tax revenue, supporting the Municipality of Chatham-Kent. Through a Community Benefits Program, SKW will also support various community causes over the life of the Project.
